DISCRIPTION OF CLASSES

Beginning Agility Class – No experience required. An introduction to agility. Individual obstacle performance, including ramps, tunnels, jumps, barrels, and hoops. Basic obstacle courses and drills.

Novice Agility Class – Experience required. Dogs must have a basic understanding of the agility obstacles. Focus is on individual obstacle performance, 6 weave poles, Novice level drills and sequences. Distance and obstacle independence.

Advanced Agility Class – Experience required. Dogs must have more than a basic understanding of the agility obstacles. Focus is on individual obstacle performance, 12 weave poles, Advanced level drills and sequences. Distance and obstacle independence.

Private Lessons – When you need expertise to work through a training issue or just need a good workout then contact Dan to schedule a private lesson.

Drop-in – You can drop into a class at any time, provided space is available. Contact Dan to make sure.
